Accountants work with the financial records of businesses or individuals to prepare financial statements. They compile, analyze, and interpret business and financial records such as income statements, balance sheets, cost studies, and tax returns in order to provide their clients with advice on financial matters.



Accounting as a Major at Notre Dame College

The accounting major is designed to prepare students to function as accounting professionals and to progress to positions of leadership in the profession. The program is designed to provide students with a thorough understanding of accounting principles; auditing, tax and reporting practices and planning; and the management of business, accounting and financial activities. This program also prepares students to pursue graduate study in the field of accounting that students majoring in the field may wish to pursue.

Notre Dame College students wishing to obtain a degree in Accounting should enroll in the Business Administration program.
