ENERGY: In March 2010 and December 2010, President Obama announced that the Pacific Coast, the Atlantic Coast, the eastern Gulf of Mexico, and much of Alaska would be off limits to offshore drilling for oil and natural gas. Many of these areas were previously open for drilling.

Last year the U.S. House of Representatives passed HR 1231 to reverse President Obama's ban on offshore drilling. The Act makes 5 year leases available to companies so they can drill under federal guidelines. ¹

Congressman Jim Renacci voted YES on HR 1231 (favoring removing the bans)²

Congresswoman Betty Sutton voted NO on HR 1231 (keeping the bans in place)³

Earlier this year another bill was passed in the House (HR 6082) to open federal leases for oil and natural gas drilling in 29 locations on the outer continental shelf.

Congresswoman Betty Sutton voted NO.4

Congressman Jim Renacci voted YES.⁵

NATIONAL DEBT: Last year the U.S. House passed HR 2560, which would have cut federal spending, put a limit on future spending, and required a balanced federal budget. This bill was commonly referred to as the "Cut, Cap, and Balance Act." It died in the U.S. Senate when the vote was tabled.

Congressman Jim Renacci voted NO on HConRes28 (supporting the completion of the mission in Afghanistan).⁹

Congressman Renacci and Congresswoman Sutton voted YES on HR 4133 in support of the strategic relationship between the United States and Israel – intended to enhance the relationship and assist in the defense of Israel.¹⁰

HEALTH CARE: Original vote on the Patient Protection and Affordable Care Act (HR 3590) – ACA/Obamacare:

Congresswoman Betty Sutton voted YES.¹¹

HR 3590 was passed before Congressman Jim Renacci was elected.

Shortly after the U.S. Supreme Court issued its ruling on the Affordable Care Act (ACA)/ Obamacare, the U.S. House of Representatives voted to repeal the entire legislation. HR 6079 passed with a vote of 244 - 185.

Congressman Renacci voted YES to repeal ACA/Obamacare.¹²

In 2011 a bill was introduced to make sure that federal funds could not be used to pay for abortions in the federal health care system. The "No Taxpayer Funding for Abortion Act" (HR 3) was passed in the U.S. House on May 4, 2011 and has been stalled in the U.S. Senate for over a year.







For times and locations, call the Secretary of State's Office (614) 466-2655 or log onto: www.sos.state.oh.us/elections.aspx

TO VOTE BY ABSENTEE:

You can request your ballot for an election beginning 90 days before the date of an election. Your request must be received by your local county board of elections by noon the third day before the election (usually a Saturday). However, you should submit your request as far in advance of the election as possible to ensure there is sufficient time for the board to mail you a ballot and for you to timely return that ballot.
