# Registration Agreement

**Payment:**

It is the policy of Notre Dame College that tuition, room, board, and fees for a given term are to be paid in full OR acceptable arrangements made by August 1 for Fall Semester, January 1 for Spring Semester, and by the first day of classes for Summer Semester. Acceptable arrangements are payment in full or signing up for a payment plan and making on-time payments. Students who register after the deadline are expected to make acceptable payment arrangements at the time of registration. Pending financial aid is not an acceptable payment arrangement. Payment information and payment plan enrollment can be accessed through the Student Accounts tab on my.NDC.edu.

**When Will I Receive My Refund?**

Students with a credit balance resulting from excess federal funds will be issued within TWO weeks of either the aid being credited to the student's account or the first day of the semester, whichever is later. All other refunds will be available 14 days after funds have been disbursed to the student's account. At the end of a 100% tuition refund period your financial aid will be reviewed and if need be adjusted based on the current enrolled hours for the semester and sub sessions in the semester.

**Refund Schedule:**

Students who withdraw from classes during the semester will have partial tuition refunds posted to their account as indicated below. Any unpaid balance (debt) will become due immediately. Refunds will be made after written notice of withdrawal is filed with the Office of the Registrar. **Please note, non-attendance does not constitute official withdrawal.** The amount of the refund will be calculated from the date appearing on the withdrawal form. Refunds are determined as follows:
